It is intended to drill and complete the subject well in the **Basin Fruitland Coal (Pool 71629)** and the **Fulcher Kutz Pictured Cliffs (Pool 77200)**. The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.

Proposed perforations are: FC - 2178' - 2424' ; PC - 2425' - 2625' **These perforations are in TVD.**

BR will use some form of the subtraction method to establish an allocation for commingled wells.
