Spud an 8-3/4" hole on 11/12/02. Set 7" 23#/ft casing. Landed at 120'. Cemented with 65 sx Class "B" neat with 3% Calcium Chloride and 1/4# celloflake/sx (77 cu ft). Circulated 3 bbls cement to surface. Pressure tested casing to 600 psi, held ok.
