11/17/03 Spud surface hole. Drilled to 130'. Ran 3 jts. (127.29") of 7", 23#, LT&C casing and set at 132' KB. Cemented with 60 sx (71 Cu.ft.) of Cl "B" with 3% CaCl<sub>2</sub> and 1/4#/sk celloflake. Circulated 3.0 bbls of good cement to surface. Pressure test to 600 psi.

11/22/03 Ran 47 jts. (2062.42') of 4-1/2", 10.5#, J-55, ST&C new casing and landed at 2067.42 KB. Insert float is at 2033.49' KB. Cemented with 200 sx (418 cu.ft.) of Cl "B" 2% econolite cement with 1/4#/sk celloflake and 5#/sk gilsonite, followed by 100 sx (123 cu.ft.) of Cl "B" with 1/4#/sk celloflake and 5#/sk gilsonite. Pressure tested to 1450psi. Float held. Circulated 5 bbls. of good cement to surface.
