It is intended to repair the casing as follows:

1. MIRU. Release packer. TOH with tubing.
2. TIH and set RBP @ 4200'. TIH with packer. Run casing inspection log. Isolate leak. Squeeze casing leak with cement. WOC.
3. TIH with bit and drill out squeeze. Test casing to 500 psi. TOH.
4. TIH and retrieve RBP. TOH.
5. TIH w/tubing and rods. Return to production.
