Spudded 8:00 A.M. August 31, 1965. Ran 66.30' of 7" 20# casing. Landed at 82.80' KB. Cemented with 35 sacks with 2 per cent CaCl. Plug down at 5:30 P.M. Drilled out from under shoe at 3:00 A.M. September 1, 1965. Drilled to 1557'. Cored from 1557 to 1636 final TD. Ran Schlumberger IES Log to 1635'. Ran 51 joints of 4-1/2" 9-1/2# J-55 casing. Landed at 1634' KB. Cemented with 55 sacks Class "C" cement. Plug down at 7:00 A.M. September 3, 1965. Perforated 1552-60 and 1563-70 with 4 jets per foot. Completed well as a water-injection well.
