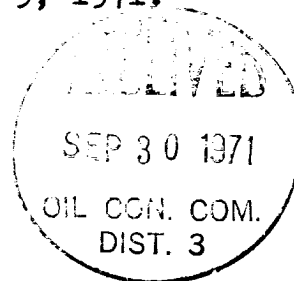

17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

This well was drilled to a total depth of 1013', having penetrated the Hospah Sand at 930' and drilling intermediate sand stringers to the depth of 1013'. However, we did not penetrate the Massive Gallup. I propose to set a cement plug from 813' to the total depth of 1013', being 200 feet. This well was spudded in the Mesaverde Formation. We drilled through the Point Lookout Formation at a total depth of 495'. We propose to set a 50 foot plug from 460' to 510' and then set a plug in the surface pipe and erect a dry hole marker. This work is scheduled to be performed on October 5, 1971.
