Request to plug & abandon

1. TIH with 2 7/8" Tbg. open ended, tag PBTD @ 1468'. Mix, pump & spot 24 sx class B cmt. @ 1468', POH to 1300', circulate hole clean, shut-in overnite, WOC
2. TIH with Tbg., tag cmt top @ 1323', mix and pump 9.0 PPG mud to fill csg, POH with Tbg. WOC
3. TIH with 5 1/2" casing cutter, cut casing @ 1200', POH with tbg., POH, lay dn. 5 1/2" csg.
4. TIH with 2 7/8" to 600', mix and pump 25 sx class B neat. (Plug @ 600'-575'), TOH with Tbg., shut down overnite. WOC
5. TIH with Tbg. Tag cmt. plug @ 575', mix and pump 9.0 PPG mud from 575'-280', POH to 280', mix and pump 25 sx class B cmt neat. (Plug @ 280'-255') POH with Tbg., shut down overnite. WOC
6. TIH with Tbg. Tag cmt, plug @ 255', mix and pump 9.0 PPG mud from 255'-130', POH with Tbg to 130', mix and pump 60 sx class B cmt neat. (Plug 130'-surface) POH with Tbg. Shut down overnite. WOC
7. Tag surface. Plug and top csg off if necessary. Install P & A marker with well ID, rehabilitate to surface location to BLM requirements.
