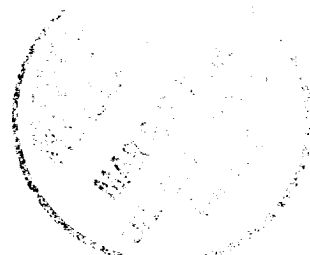

THIS AMENDMENT IS TO EXTEND THE DRILLING DATE BEYOND THE PREVIOUS EXPIRING DATE OF MARCH 10, 1982 WHICH WAS ORIGINALLY APPROVED ON SEPTEMBER 10, 1981. THE REASON FOR THE REQUESTED EXTENSION IS THAT WE WERE DELAYED IN DRILLING BECAUSE OF NEGOTIATIONS WITH THE NAVAJO NATION WHO CONTROLS THE SURFACE.
