1. Spud 12 1/4" hole on 11/16/81 and drill to 44' GL.
2. Set 8 5/8", 23# surface casing at 43.5 ft., cement to surface.
3. Drill 7 7/8" hole to TD of 1640 ft. (11/18/81).
4. Run induction electric logs (IES) w/SP and GR from 1640-1200 ft.
5. Ran 5 1/2", 14# casing and landed at 1634 ft. Cemented casing w/80 sks. class "B" w/1% CaCl₂. Estimated cement top at 1200 ft.
6. Prep. to complete well in the Lower Hospah formation.
