As per our phone conversation on 6-11-82, we have changed the name of the referenced well to the Seco NM-AZ Land Co. 1 #3. Our computer does not accept a dash in the number of a well and there was already a Seco NM-AZ Land Co. 1 #2. Memorandum #2-65 states all wells on the same lease must be numbered in an orderly sequence. You must submit a C-103, sundry notice changing the well number or it will impede future processing of this well. If you wish to change it to any other number you will have to submit 2 C-103's showing the change from the 1 #2 to the 1 #3 and from the 1 #3 to ?.
