Production was suspended October 10, 1986 when the gas purchaser (Gas Company of New Mexico), reduced the purchase price to levels insufficient to meet monthly operating expenses. Given the current condition of the domestic natural gas market, operator expects prices to rise in the near future, restoring economic operation to this well.

Operator requests a one year extension of temporary abandonment status.
