Bird Oil Corp. requests approval to centralize production facilities for operations in the Torreon Area. Production from 1) Bird Federal 12-5 (SWNW Sec. 12, T19N, R5W); 2) Bird Federal 12-11 (NESW Sec. 12, T19N, R5W); 3) Bird Federal 12-13 (SWSW Sec. 12, T19N, R5W); can be gathered treated, and stored on the northeast corner of Woosley Oil's FBC #1 location (NWSW Sec. 12, T19N, R5W), shown in Figure 1. New facilities proposed are 2 - 400 bbl production tanks; and 1 production unit, see Figure 1.

The proposed buried gathering line route is shown in Figure 2. The ownership for all three wells is common. Restoration of surface for buried gathering lines will follow Bureau of Land Management instructions.

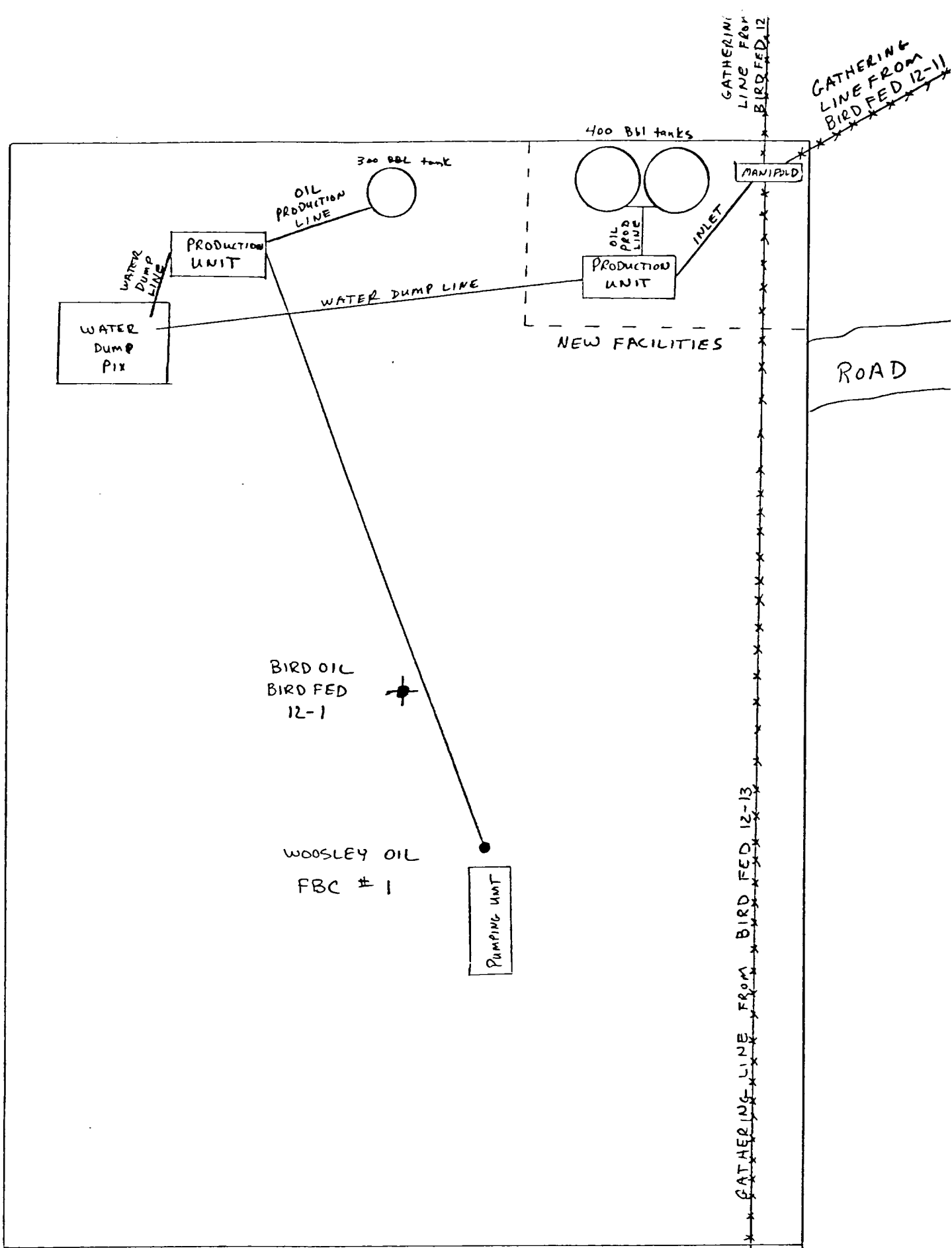

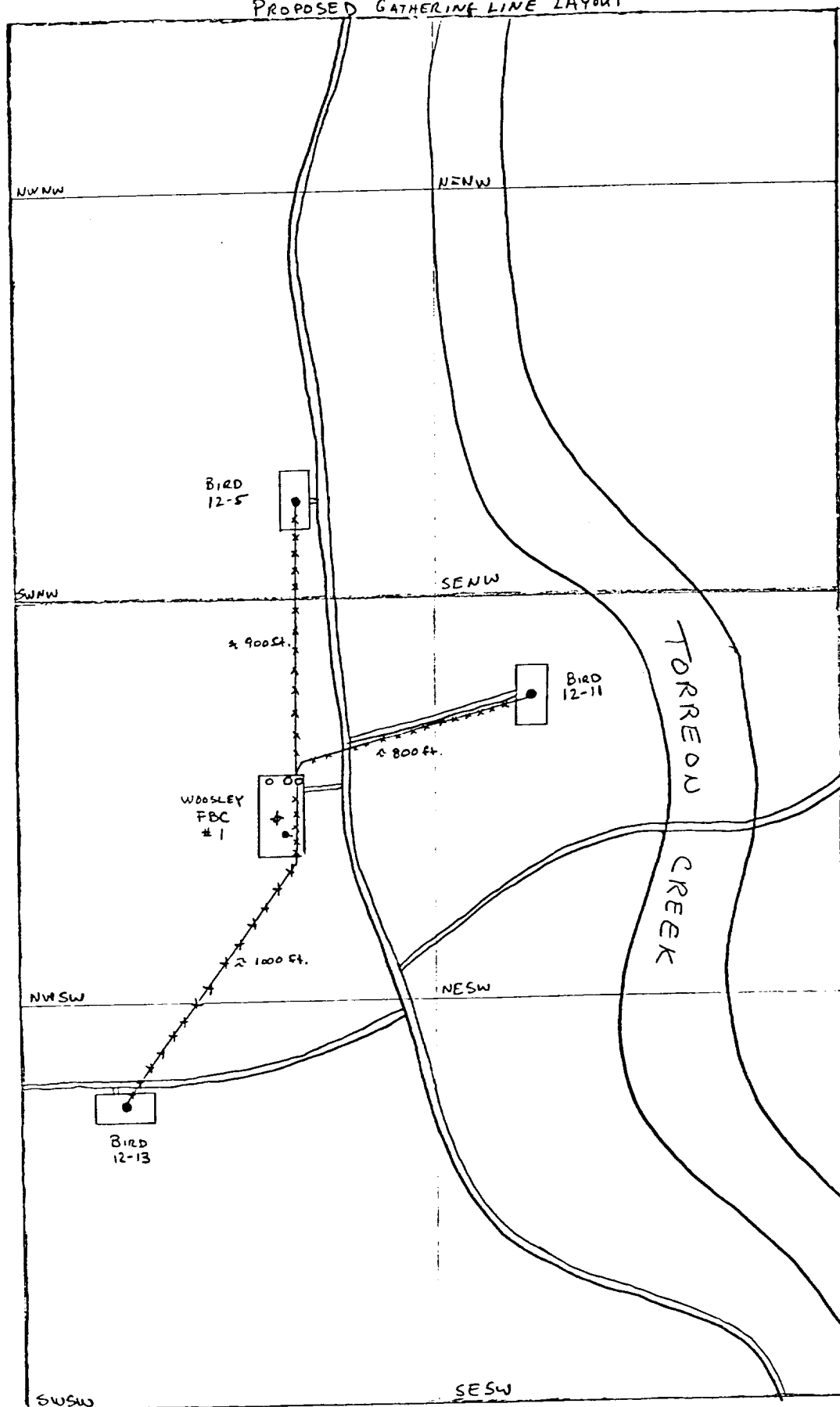


BIRD OIL CORPORATION
