Merrion Oil & Gas was required to resume production of this well by December 1, 1996. We now plan to tie the McCollum #1 to the gathering and compression system which serves this well. The McCollum #1 Upper Menefee perms have been squeezed, and the cement and CIBP are currently being drilled out. We will test the McCollum #1 to determine volume and pressure of the gas in order to properly size the compressor. The compressor changeout will be done as quickly as possible, however with winter weather and holidays in December, we request that the deadline to return the Pot Mesa #1 to production be extended to February 3, 1997.
