Merrion Oil & Gas filed a sundry to plug and abandon the subject wellbore. We subsequently added additional perfs and refraced the Corrales No. 2. It is making a large volume of water, indicating excellent productivity. We anticipate that the well may produce gas in paying quantities. Merrion proposes to delay the plugging of this field until we have conclusive results on the stimulation. If test results are promising, we will workover the subject well.
