FOR RUTTER AND WILBANKS CORPORATION'S FAJADA WASH 7 #2 OIL WELL
1110' FNL & 2390' FEL SEC. 7, T. 20 N., R. 10 W., MCKINLEY COUNTY, NM

- I. The well is on Navajo Tribal fee surface and a private oil and gas lease. The proposed location is non-standard (210' from the south quarter-quarter line and 250' from the west quarter-quarter line instead of the standard minimum 330'). The APD is attached.
- II. A C-102 showing the well location and proration unit (NWNE of Sec. 7 which totals 40.00 acres) and lease (all of Sec. 7 which totals 638.28 ac. and is part of a several thousand acre lease including as a minimum all of 7-20n-10w) is attached. A General Land Office survey plat is also attached which shows Section 7.
- III. According to NM Oil Conservation Records, there is no production of any kind within a mile radius. The closest known proposed well is Rutter and Wilbanks' Fajada Wash 7 #1 which is 1,256' southeast. A copy of the Seven Lakes NW 7.5' USGS map is attached showing the proposed well (rectangle), spacing units (thin solid lines), and lease (thick solid line). There is only one lease within a minimum 1,110' radius. Rutter and Wilbanks is the operator of all oil and gas interests in its private lease. The closest non-Rutter and Wilbanks lease (1,110' north) is unleased Navajo Tribal oil and gas minerals in 6-20n-10w. A registered letter was sent on April 25 to the Navajo Nation Minerals Dept. A copy of the receipt and letter will be provided.
- IV. A copy of the Seven Lakes NW 7.5' USGS map is attached. The proposed well is marked by a rectangle. Proration units (quarter-quarters) are marked by thin lines.
- V. Rutter and Wilbanks selected its location based on a 1998 3-D seismic survey with lines. A standard drilling window does not overlap the top of the indicated reservoir (see attached CONFIDENTIAL Entrada structure map from the seismic survey).

VI. No archaeology sites were found.

VII. Surface conditions are not an issue.

VIII. Directional drilling is not feasible because it is not cost effective for this wildcat well at current low oil prices.
