5. If casing is run, cement 4 1/2", 9.5# at T. D. with 100 sax.
6. Perforate productive zone with 2 jets per ft. and frac with 40,000 gals. water, 40,000 lbs. sand.
7. Run 2 3/8" tubing and swab well in for test.

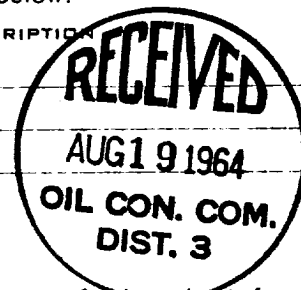

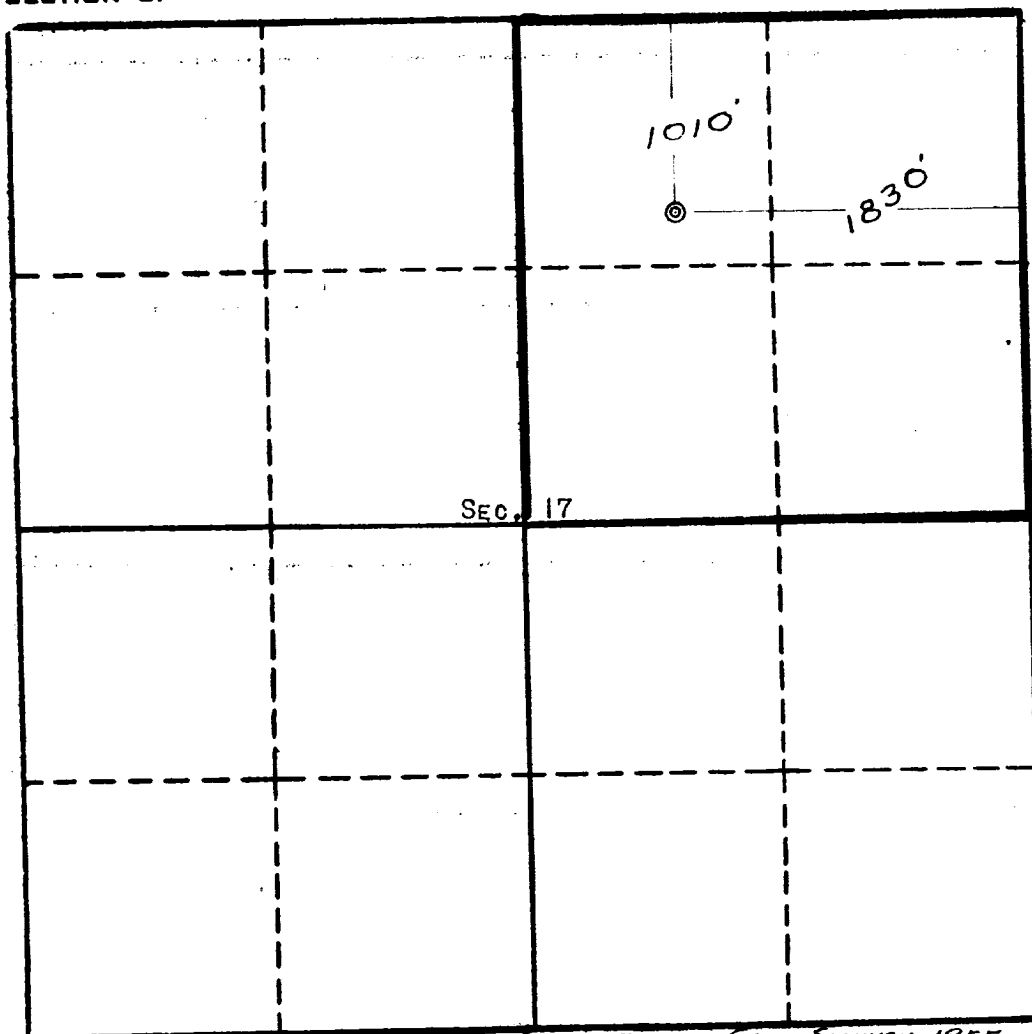
