7-16-54: Drill stem test #2 from 3789 to 3844'. Tool open 40 minutes. Leak blow at surface which died after 15 minutes. Initial and final mud pressure 1890. Min and max flow 0. One inch top and 3/4" bottom chokes. Build up after 20 minutes 475. Test satisfactory.

Went back in hole with bit and reamed core hole; resumed drilling.
