MIRU Triple P- PU packer and bridge plug - isolated 718' bad casing from 3339'-4057'. Squeezed same w/ total of 760 sx Class "B" cement in 3 squeeze attempts. Pressure built to 1700 psi at end of squeeze. Bled back to 1400 psi at shut down. WOC 24 hrs. Drill out cement and test squeeze to 500 psi. Clean out to PBTD. TIH w/ 2 3/8" production string and land @ 5785'. Swab well in. Kicked off after 15 swab runs. Shut well in for 12 hrs to build up pressure. Built to 510 psi. Install plunger lift. Put well down the sales line.
