TD - 5710'. Ran 136 joints, 4 1/2", 11.6 lb., J-55 casing. Measured 5703', set at 5703'. Float collar - 5658' (KB), Stage collar - 3420' (KB). First stage cemented as follows:

Pump 10 bbls. fresh water, 10 bbls. CaCl² water, 10 bbls. fresh water, 12 bbls. Flocheck-21, 10 bbls. water spacer followed by 280 sacks, (510 cubic ft.) 65-35 pozmix, followed by 100 sx. 50/50 poz (140 cubic feet); 6% 6 1/4 lbs. Gilsonite and 6 lbs. salt per sack. Plug down.

Circulated cement by stage collar. Circulated 4 hours between stages.

Second stage - same spacer program as the first stage followed by 540 sacks. (983 cubic ft.) 65-35 pozmix, 12% gel, 6 1/4 lbs. Gilsonite per sack followed by 50 sacks, (59 cubic ft.) Class "B" cement and circulated to surface. Plug down.
