8-2-97 WOC. NU BOP. PT BOP & csg to 600 psi/30 min, OK. Drilling ahead.

8-4-97 Drill to intermediate TD @ 3289'. Circ hole clean. TOOH. TIH w/79 jts 7" 20# K-55 LT&C csg, set @ 3272'. Pump 5 bbl well flush, 25 bbl wtr ahead. Cmdt w/360 sx Class "G" 50/50 poz w/2% gel foamed w/nitrogen (522 cu.ft.). Tailed w/110 sx Class "G" 50/50 poz w/2% gel, 0.5% accelerator, 2% calcium chloride (135 cu.ft.). No cmt circ to surface. WOC. PT BOP & csg to 1500 psi/30 min. Drilling ahead.
