Spud well on 2-24-02. Drilled 12-1/4 hole to 365' KB. Ran 8-jts 8-5/8, 24#, J-55 STC casing set @ 360.96' KB. Cemented with 300 sx Class "B", 2% CC. Displace 20 bbls water. Plug down @ 4:15 PM on 2-24-02. Circulate 20 bbls cement to surface. Drilled 7-7/8 to 5712' KB. TD reached @ 4:45 PM on 03-11-02. Ran 151-joints 4-1/2, N80, 11.6# LTC casing set @ 6732.11' KB. Stage tool set @ 4642'.KB. Cemented first stage w/685 sx 50/50 H POZ, 2% gel, 5# gilsonite, 1/4# Flocele, .5% HALAD-9. Bump plug w/1850 PSI and open stage tool. Circulate 4 hours and 10 bbls cement to surface. Cement 2nd stage w/875 sx 65/35 STD POZ, 6% gel, 1/4# flocele, 10# gilsonite, 1% CC and 50 sx H POZ, 1/4# flocele, .5% HALAD-9, .2% CFR3. Drop plug and close stage tool w/2200 PSI - plug held. Circulate 110 bbls to surface. Plug down @ 9:30 PM on 03-12-02. Rig down cementers. Set slips. Cut off casing. Release rig. Install wellhead.
