DETAILS OF WORK

Subject well spudded August 21, 1962. Set 8 5/8" surface casing at 97' and cemented with 60 sacks. Total depth of 3170' reached August 24, 1962. Ran 4 1/2" casing to 3167' and cemented with 75 sacks. Well was perforated from 3000' to 3029' with 2 shots per ft. and sand fraced on August 27, 1962 with 34,350 gallons of water and 30,000 sand.

Well presently awaiting testing.

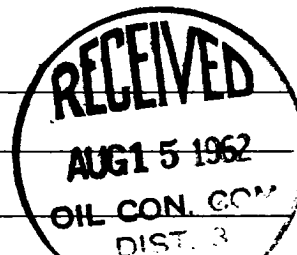

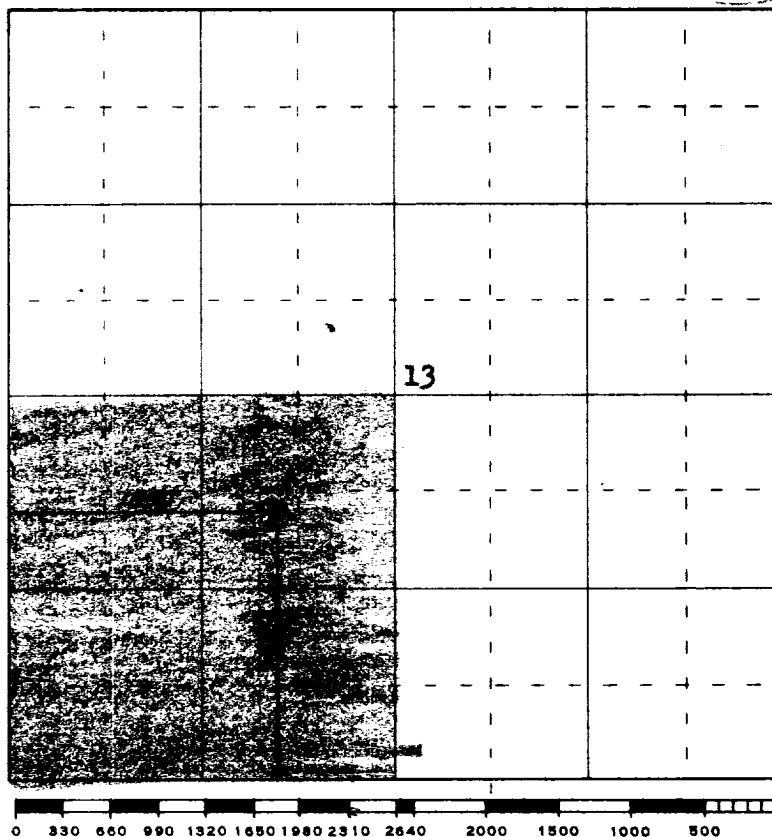
