HOLE WAS SPUDDED ON MAY 25, 1968, DRILLED TO A TOTAL DEPTH OF 540 FEET WITH NO SHOWS, NO CORES, NO TESTS AND NO ELECTRIC LOGS. DRY AND ABANDONED ON MAY 26, 1968.

INASMUCH AS THE FORMATIONS CONSISTED MAINLY OF GRAY SHALES AND VERY HARD GRAY, BENTONITIC SANDSTONES WITH NO POROSITY, I PROPOSE FILLING HOLE WITH DRILLING MUD TO A DEPTH OF 135' BELOW SURFACE AND PLUGGING TO SURFACE WITH 15 BAGS OF CEMENT, INSERTING THE STANDARD "DRY HOLE MARKER".

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
