On November 19, 1973 a 120 hp Type 54G Rada was installed on Fluid Power Pump #1 Well. The well is currently producing 550 BOPD and 3,500 BWPD. Oil cut 13.6%.

Before installation of Rada, well was pumping 220 BOPD and 2,000 BWPD. Oil cut 10.0%.

Instructions
