On May 21, 1973 the 4-1/2" casing was set at 2913' and cemented with 550 sacks 50-50 Class "C" Pernix with 6X Gel and 2 pounds Tuf Plug per sack and 100 sacks Class "C" Neat. The cement circulated. The casing was tested with 3000 psi OK.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
