Moved in service unit June 14, 1973, tested blowout preventer and casing with 3250 psig OK and ran log. Perforated 2774-87', 2791-95', 2798-2804', 2808-10' with 1 SPF. Displaced hole with treated water and spotted 500 gallons 15% HCl and displaced. Breakdown pressure was 2200 and AIR 3 BPM. Sand-water fraced with 45,810 gallons treated water (1% KCl and 10 pounds Gel per 1000 gallons) and 5,000 pounds 20-40 sand, 20,000 pounds 10-20 sand, and 10,000 pounds 8-12 sand. Treating pressures: Maximum 1900, average 1800. AIR 45 BPH.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
