Gary-Williams Oil Producer, Inc. respectfully requests permission to produce the Johnson 6, #16 as follows: shut in for 2 months, then swab the well in and produce the equivalent of two months allowable in one continuous flow period.

The reason for this request is that when this well is shut-in, it loads itself up and must be swabbed in to return the well to production. Production from the Johnson 6, #16 is curtailed by the 30 mcf/d venting restriction.

Since this well must be swabbed in each time, it is marginally economical to produce at all. If GWOP were allowed to produce this well as requested, rig costs would be cut by 50%, making the production profitable.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
