However based on the industry wide economic status at this time, we feel that all parties would go non-consent on an AFE to complete and equip this well. GWOP requests permission to delay any completion attempt until no later than 2 years after spud date which would be December 11, 1986. Hopefully economics will improve by that time. In the event that economics do not improve, GWOP will propose establishing commercial production if possible rather than allow potential reserves to go untested. Thank you for your consideration.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
