The same B.O.P. was just approved a couple of weeks ago, for a 1500 ft hole by the Farmington B.L.M., for federal well #F1-1 for section 1, T18 N/R 4W and was just completed last Friday by Ludwick. Attached are the only 2 sheets on the B.O.P. which was given to me by Mr. Ludwick. It was approved for a 1500 ft. hole, it should be alright for my 370 ft. hole.

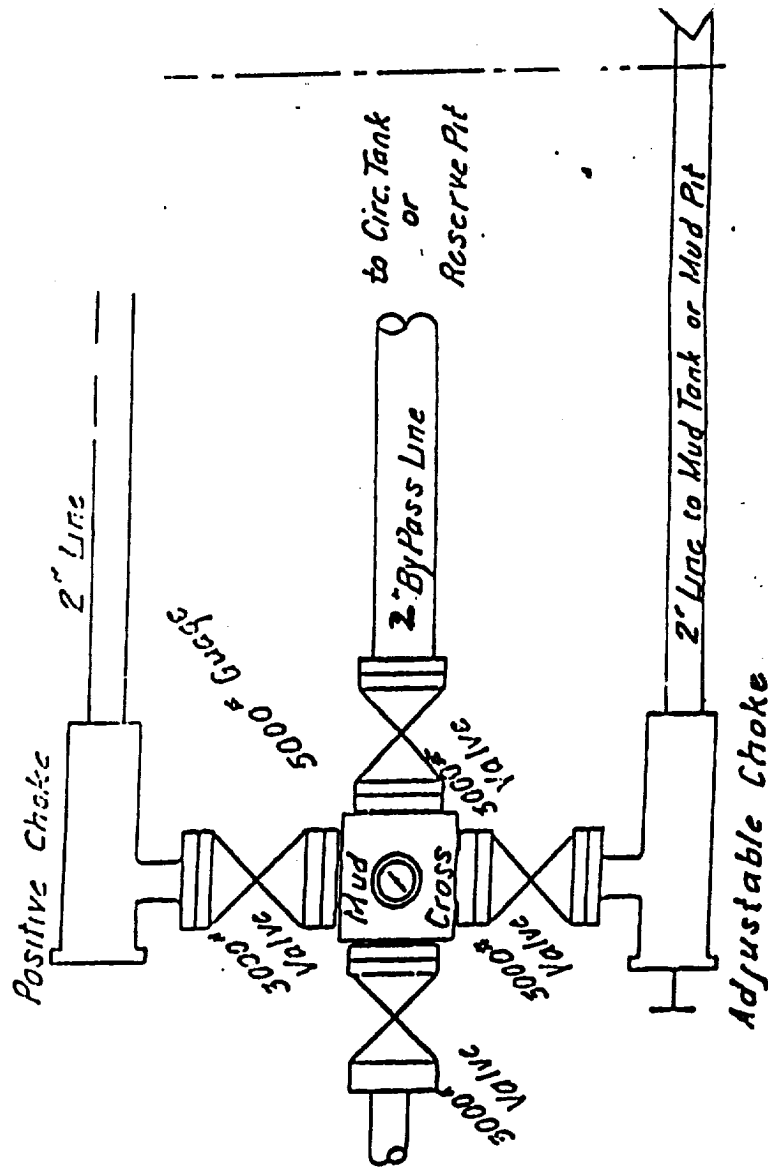
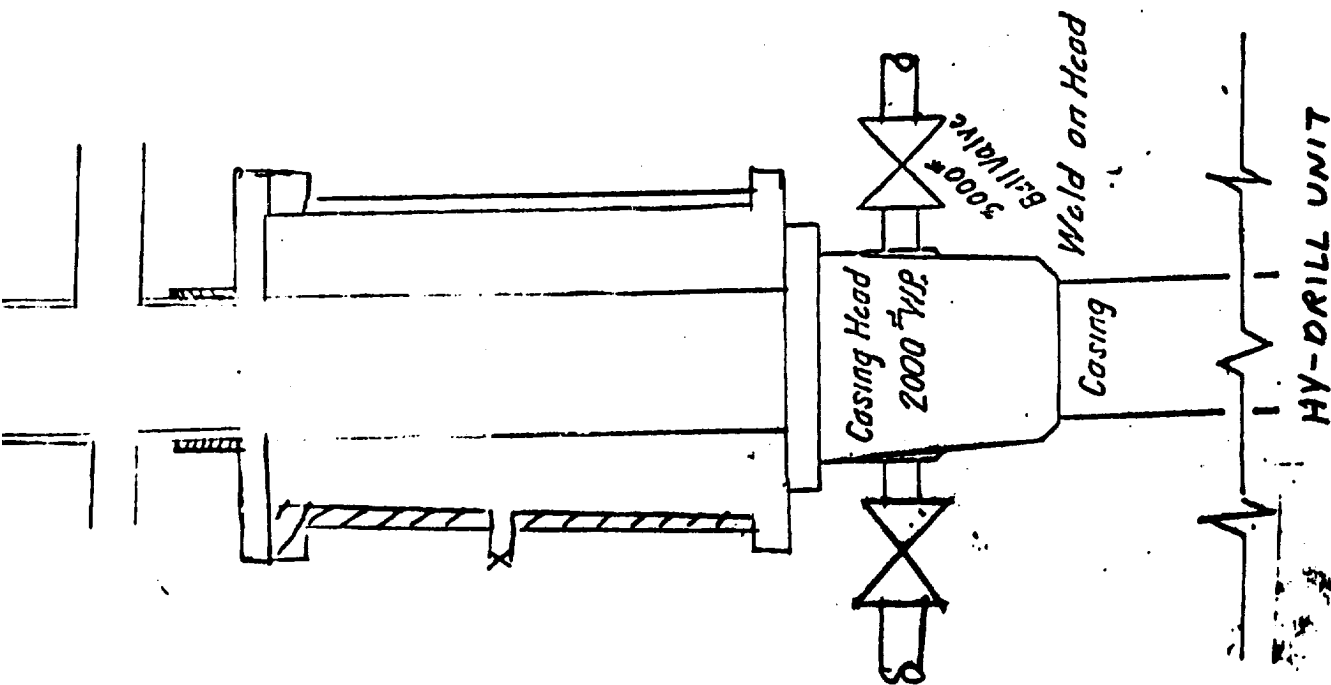
