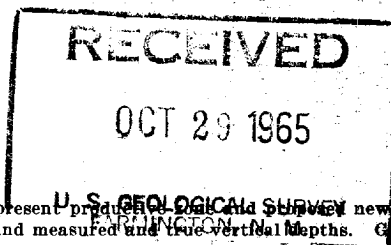

Instructions

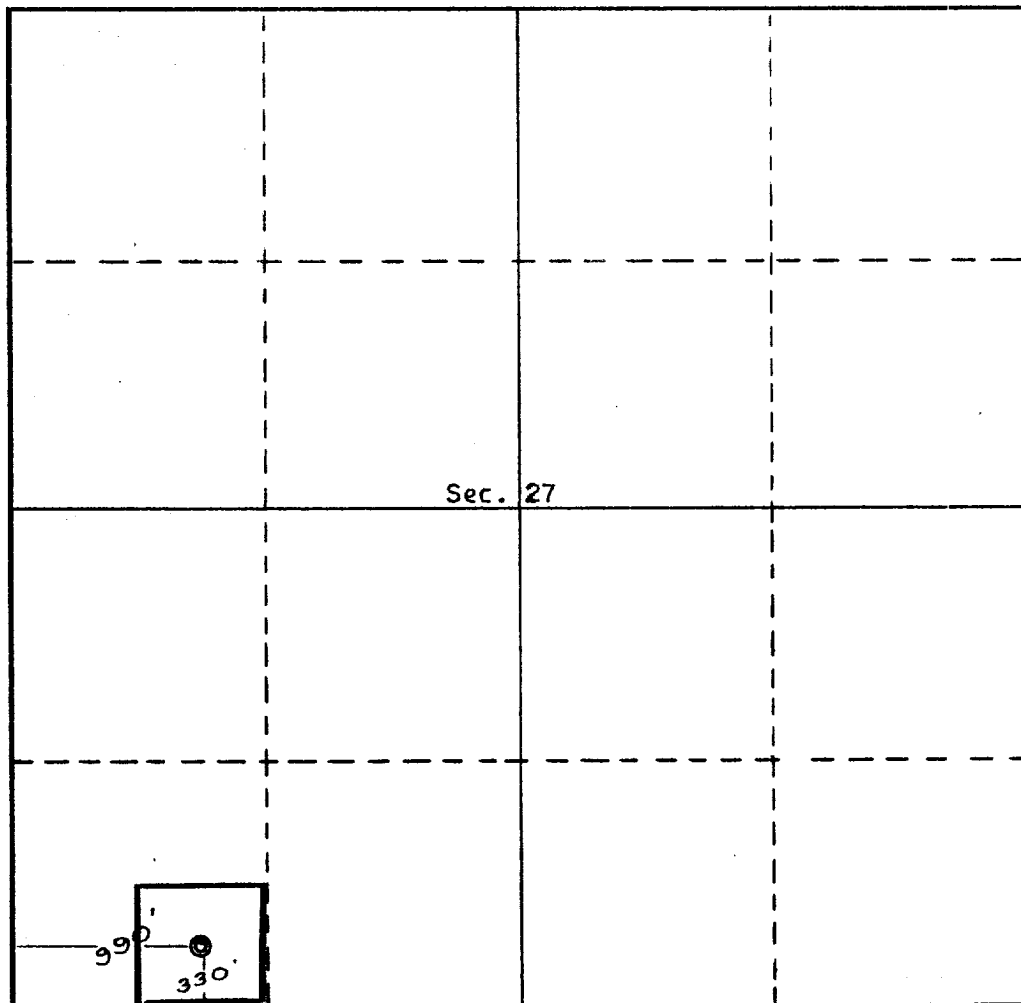
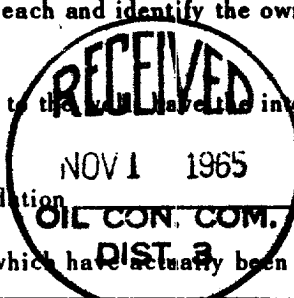
