Moved in & rigged up Four Corners Drilling Company Rig #6. Spudded a 12 1/4" hole at 4:15 PM 8-20-94. Drilled to 236' RKB. Ran 5 jts. 8-5/8" OD, 24#, 8 Rd, ST&C casing (T.E. 216') set @ 227' RKB. Cemented with 150 sx (177 cu.ft.) class "B" cement with 2% CaCl₂. P.O.B. at 11:30 PM. Circulated 5 bbls cement to surface.

Pressure test surface casing & BOP 1500 psi 30 minutes -held OK.
