Move in & rig up Smith Drilling. Spud 9-1/8" hole at 1130 hrs on 10/24/94. Drilled surface to 130'. Circulate hole. TOH with bit. TIH with 3 jts. 7" 26# K-55 casing landed at 122'. Pump 5 bbls water. Cement with 50 sx neat cement (59 cu.ft.). Displace with 4 bbls water. Finish at 1530 10/24/94. Circulate 2 bbls cement.

10-25-94 Nipple up BOP. Pressure test to 600 psi - OK.
