Plan to run IES and CDL logs. If determined productive, will run 4 1/2", 10.5#, J-55 casing with stage tool, selectively perforate, frac, clean out after frac and complete well.

BOP & related equipment will be for 2000 psi system. No abnormal pressure or hazardous zones are anticipated.
