Moved in & rigged up Four Corners Drilling Company Rig #6. Spudded a 12 1/4" hole @ 3:30 PM 2-27-96. Drilled to 247'. Ran 5 jts. 8-5/8" OD, 24#, K-55, 8 Rd, ST&C casing (T.E. 221') set @ 233' RKB. Cemented with 150 sx class "B" with 2% CaCl₂ (total cement slurry = 177 cu.ft.). Good mud returns while cementing. Circulated 3 bbls cement to surface. P.O.B. @ 8:00 PM 2-27-96.

Pressure tested BOP and surface casing 600 psi for 30 minutes - held OK.
