7' Casing was cemented at 2275' by Halliburton. Mudded open hole to 2275' with 10 lb. mud. Ran cement plug from 2275' to 2175'.

Converted to a Water Well for Owners use by pulling 12-5/8' and 10' Casing and also 1499' of 7' Casing leaving 8' at 1613' and 7' from 1499 to 2275'.

Perforated the 8' Casing with 50 holes from 791' to 1461'.

Well is now flowing fresh water.
