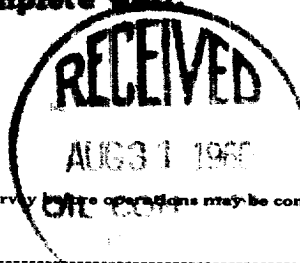

D. casing to total depth cemented with sufficient cement to cover Gallup formation, approximately 150 sz. Perforate and sand oil fracture Gallup formation, run tubing and complete well.

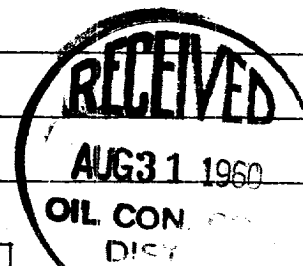
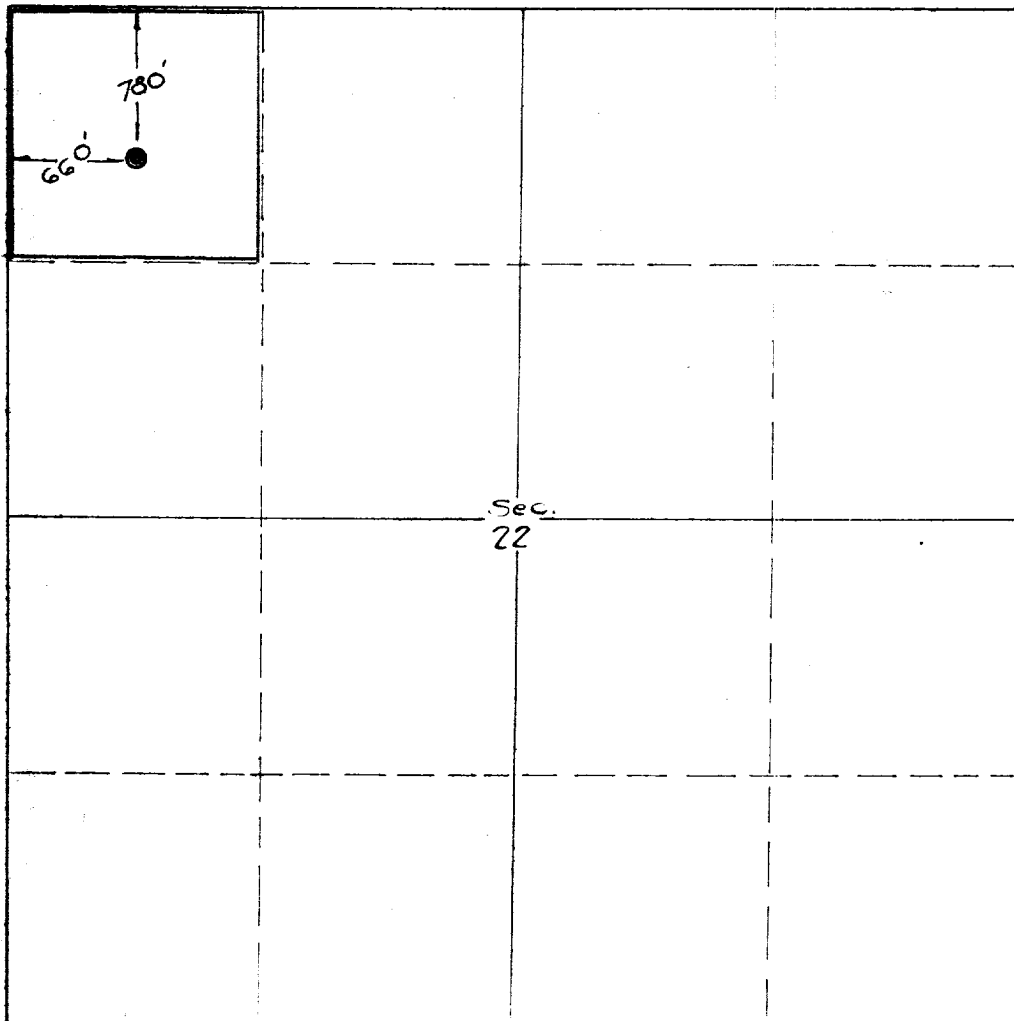
