Production String: If productive, will set production string to total depth and cement with sufficient cement to protect Dakota & Gallup Zones, and second stage through staging tool approximately 100' below Pictured Cliffs and cement with sufficient cement to protect Pictured Cliffs Zone.

Lease consists of all of secs. 15, 16, 21 and 22, T24N, R4W, Rio Arriba County, New Mex.

NOTE: This location moved 44' West to read 790' from East line of Unit Boundary, to conform with rules and regulations governing the Basin Dakota Pool. This cancels original "Notice of Intention to Drill" filed 9/28/62.

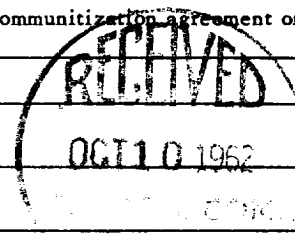

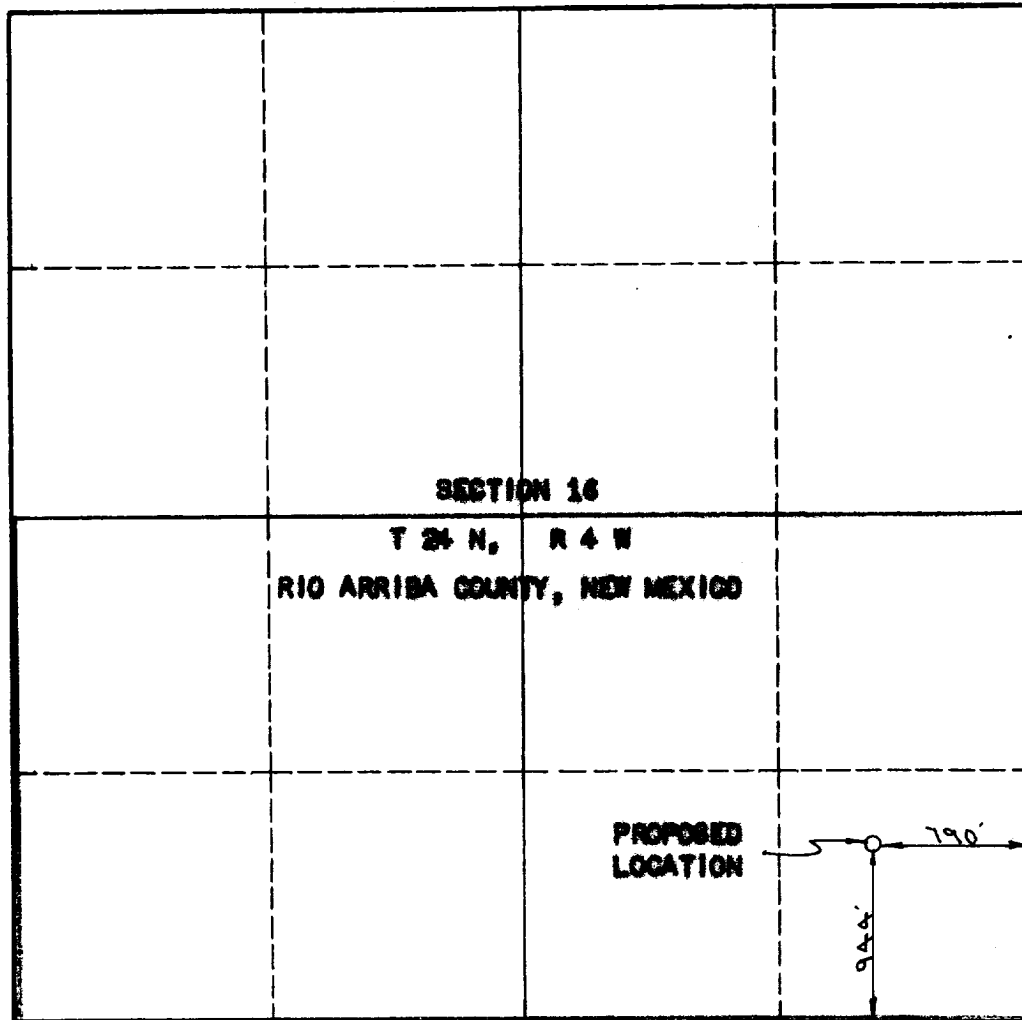
