The log log paper used for plotting the back pressure curve shall be of at least three inch cycles.

- Pc 72 hour wellhead shut-in casing (or tubing) pressure whichever is greater.
- Pw Static wellhead working pressure as determined at the end of flow period. (Casing if flowing thru tubing, tubing if flowing thru casing.) psia
- Pt Flowing wellhead pressure (tubing if flowing through tubing, casing if flowing through casing.)
- Pf Meter pressure, psia.
- hw Differential meter pressure, inches water.
- Fg Gravity correction factor.
- Ft Flowing temperature correction factor.
