DETAILS OF WORK

Our change of plan is to temporarily abandon Navajo well No. 2, leaving the 5-1/2" casing in the hole. The perforations have been squeezed off and the top of the cement in the casing is at 2100'. Casing is to be capped off on surface.

It was decided to delay pulling the 5-1/2" casing from this well with the idea that in the future it might serve as a water supply well for secondary recovery operations which might be initiated on the Navajo "F" and "G" leases.

I understand that this plan of work must receive approval in writing by the Geological Survey before operation.
