THE APPLICATION OF SKELLY OIL COMPANY FOR PERMISSION TO EFFECT BUAL COMPLETION OF ITS JICARILLA "C" WELL NO. 10, LOCATED IN THE SW/L SW/L OF SECTION 22, TOWNSHIP 25 NORTH, RANGE 5 WEST, MIPH, RIO ARRIBA COUNTY, NEW MEXICO IN THE SOUTH BLANCO PICTURED CLIFFS GAS POOL AND A UNDESIGNATED CHACRA GAS POOL.

## ADMINISTRATIVE ORDER OF THE CIL CONSERVATION CONVISSION

Under the provintens of Rule 112-A (c) Skelly Oil Company made application to the New Maxice Sil Conservation Commission on December 31, 1956, for permission to dually complete its Jicarilla "C" Well No. 10, located 1190 feet from the South line and 1190 feet from the South line and 1190 feet from the South line and 1190 feet from the South Si/k Si/k of Section 22, Township 25 Marth, Range 5 Nest, NHPM, Rie Arriba County, New Mexico, in the South Blames Pictured Cliffs Gas Pool and an undesignated Chacra Gas Pool.

## The Secretary-Director Finds:

- (1) That application has been duly filed under the provisions of Subsection 'o' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisficatory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.

## IT IS THEREFORE CELERED:

That the applicant, herein, Shelly Oil Company be and it hereby is authorised to dually complete its Jicarilla "G" Well No. 10, located in the SW/k SW/k of Section 22, Newship 25 North, Range 5 West, NMPM, Ric Arriba County, New Mexico, in such memmer as to permit production of gas from the Pictured Cliffs formation by proper perforation of the casing from South Blance Pictured Cliffs Gas Pool with gas produced through the casing-tubing annulus and with the production of gas from the Chacra Sandstone formation by proper perforation of the casing of an undesignated Chacra Gas Pool with gas produced through the tubing and with the installation of a suitable packer and with the installation of adequate surface equipment to maintain complete separation of the two separate sones of production.

PROVIDED HOWEVER. That subject well shall be completed and thereafter produced in such a manner that there will be no commingling within the well-bore, either within or subside the casing of gas, oil and gas, or oil produced from either or both of the separate strata,

PROVIDED HOWEVER, That prior to the actual dual completion the operator shall make pressure tests of the casing to prove that no casing leaks have developed since the well was originally completed. In the event a casing leak is apparent the operator shall take appropriate steps to adequately repair the leak. The results of these tests shall be reported to the Commission on Form

PROVIDED FURTHER. That upon the actual dual completion of such subject well applicant shall submit to the appropriate District Office of the Commission, copies of Oil Conservation Commission Form C-10h, Form C-110 and Form C-122 outlining the information required on those forms by existing Rules and Regulations and two sepies of the electric log of the well.

PROVIDED FURTHER, That said subject well for dual completion and production shall be equipped in such a way that reservoir pressures may be determined separately far each of the two specified strate, and further, be equipped with all necessary connections required to permit recording meters to be installed and used, at any time, as may be required by the Commission or its representatives, in order that natural gas, oil, or oil and gas from each separate stratum may be accurately measured and the gas-liquid ratios thereof determined, and

PROVIDED FURTHER, That the operator-applicant shall make any and all tests, including segregation tests, packer leakage tests on completion and during the annual deliverability test of the South Blance-Pictured Cliffs Peel, but not excluding other tests and/or determinations at any convenient time and in such manner as deemed macessary by the Commission; the original and all subsequent tests shall be witnessed by representatives of the Commission and by representatives of effect operators, if any there be, at their election, and the results of each mest properly attested to by the applicant herein and all witnesses and shall be filed with the Commission within fifteen (15) days after completion of such test, and submit a packer setting affadavit within fifteen (15) days after completion, after remedial work, or whenever the packer is disturbed, and

PROVIDED FURTHER, That upon the actual dual completion of such subject well, applicant shall select to the Commission a diagrammatic sketch of the mechanical installation which was actually used to complete and produce the seal between the strate, and a special report of production, gas-liquid ratios and reservoir pressure determination of each producing some or stratum immediately following completion.

IT IS FURTHER CREEKED, That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after prepar notice and hearing the Commission may terminate the authority hereby granted and require applicant or its successors and assigns to limit its activities to regular single-some production in the interests of conservation.
