DETAILS OF WORK

It is our intention to drill Well No. 2 to approximately 3900' to test the Pictured Cliffs formation. Our casing program is as follows:

Run of 10-3/4" casing, 12.75 lb., SR, 20 ft. x 40, cemented with 150 lbs. regular cement, to be circulated.

3900' of 7" casing, 20 lb., SR, 20 ft. x 40, cemented with 200 lbs. regular cement.

The designated drilling unit is the NW/4 of Section 19-35N-3E, Lytle Bentz County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

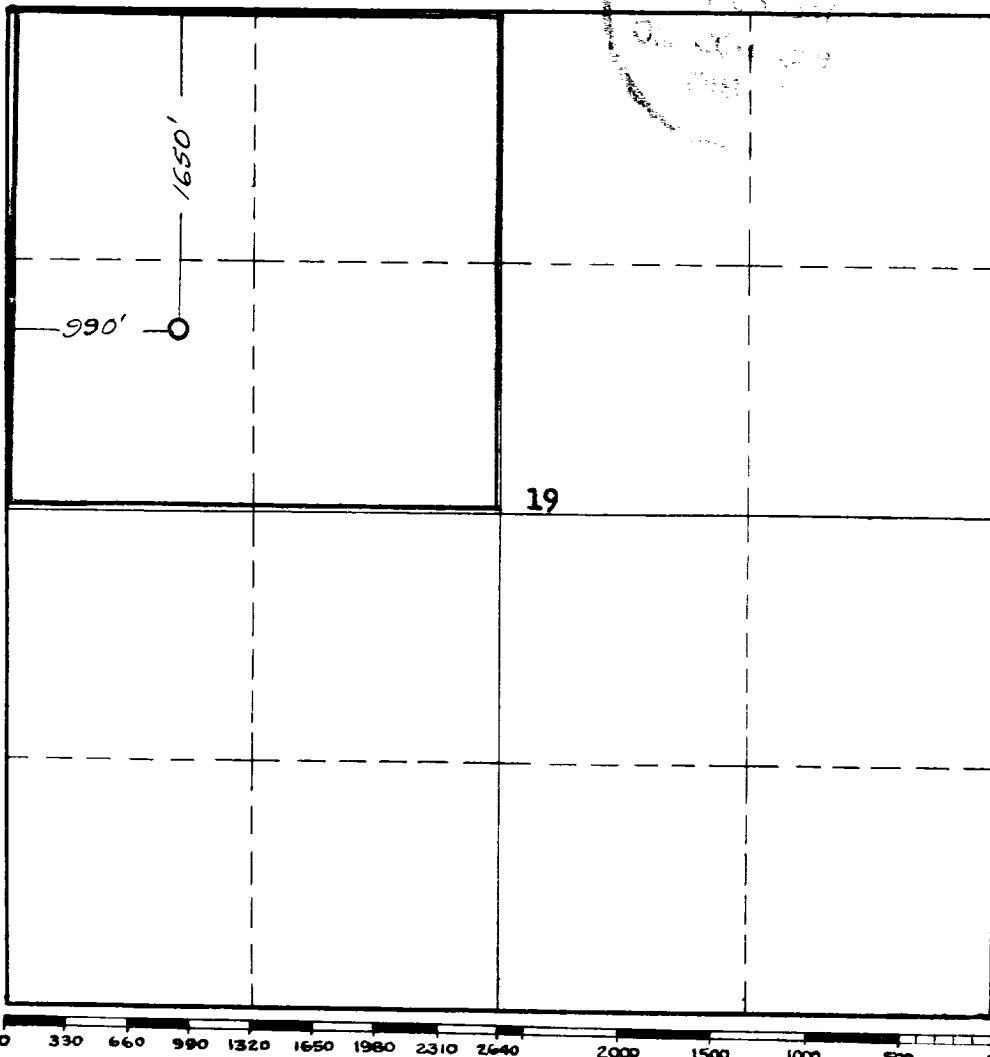
