Dear Mr. Blatra.

We have just received Form C-104, Well Record Form, for your #2 Walter Howard well in the NE_4^1 Section 22-25N-2W. In checking our file we find that you have not complied with the New Mexico Oil Commission Rules and Regulations in the following instances:

First, Form C-103 has not been filed showing that casing tests were run on either surface or production casing strings, as required by Commission Rule 107. This rule states "On all wells drilled with rotary tools the casing shall be tested with pressure of not less than 600 pounds per square inch for a period of not less than 30 minutes." The rule further states that if a drop of more than 10% of the test pressure should occur the casing shall be considered defective and corrective measures shall be applied.

You have also stated on the Well Record Form that an attempt to fracture was made through perforations 3372-80' and that it was found that communication existed with the open hole. If communication exists between the pay zone and the annulus behind the casing immediate steps should be taken to squeeze the perforations so that the pay zone is permanently separated. We are, therefore, directing that this be done immediately. If you have any questions regarding the above matter, please contact this office.
