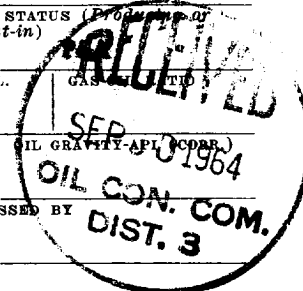

INSTRUCTIONS
