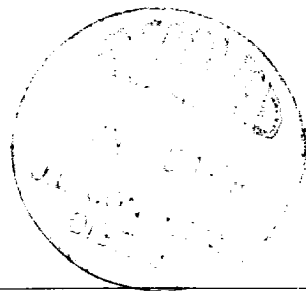

On 5-20-68 T. D. 3261'. Ran 106 joints plus one 10' pup 2 7/8", 6.4#, J-55 casing (3251') set at 3261' w/100 sacks of cement. W.O.C. 18 hours.

On 5-29-68 P.B.T.D. 3240', tested casing to 4000# O. K. Perf. 3148-72', 3197-3203' w/24 SPZ. Frac w/35,000# 10/20 sand, 35,940 gal. water. Max. pr. 4000#, BHP 3200#, tr. pr. avg. 2800#. I.R. 36 EFM. Dropped 1 set of 24 balls, flushed. ISIP 600#, 5 Min. 450#, 30 Min. 245#.
