Commenced drilling 5-10-69. 8 5/8" OD, 2 3/4" casing set at 203' RBN and cemented with 165 sacks cement, 2% CaCl₂. Plug down 5 A.M., 5-11-69. WOC. Tested to 1000 psi for 30 minutes. Okay. Drilled to total depth 7953'. 5 1/2" OD, 17 1/2' & 15.5' casing set at 7953'. Cemented first stage with 375 sacks 50-50 Pozmix "A", 2% gel, 6 1/4#/sack Gilsonite, 1/2 of 1% GFR2. Second stage cemented with 120 sacks Liteweight, 1/2 of 1% D-30 followed by 300 sacks 50-50 Pozmix "A", 2% gel, 6 1/4#/sack Gilsonite, 1/2 of 1% GFR2. Both stages preceded with 500 gallons mud sweep. Circulated three hours between stages. Plug down at 11:15 P.M., 6-1-69. Released rig 3 A.M. 6-2-69.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
