7-5-69: T. D. 3565'. Ran 119 joints 2 7/8", 6.4", K-55 casing, 3554' set at 3565' w/250 sacks cement. W.O.C. until completion.

7-23-67: P.B.T.D. 3555'. Perforate 3300-3406', 3486-38' w/24 SPZ. Sand water traced w/29,525# 20/40 sand, 27,346 gallon water, flushed with 924 gallon water, dropped 1 set of 24 balls.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
