The above referenced gas well is experiencing severe problems with liquids accumulating in the wellbore. The well is presently logged off. We intend to determine if this well has a casing leak. If a casing leak is present we will locate and cement squeeze the hole in the casing; 100 sacks of Class "B" Neat cement will be used with which to squeeze. If no casing leak is present we will determine the water productive zone and isolate this zone from the wellbore.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
