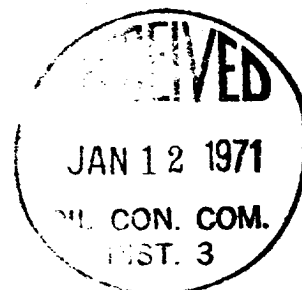

12-18-70 Temperature survey showed top of cement at 4450'.

Pressured up on casing to 1000#. No pressure decrease in one hour.

Instructions
