Spudded 2-1-72, drilled to TD 7525', PBTD 7498'. Ran 8 5/8" 24# K-55 casing set at 244' and cemented with 150 sacks Class "A" and 2% CaCl₂. Ran 4 1/2" 10.5# K-55 casing set at 7525' with float collar at 7498' and stage collar at 5336'. Cemented first stage with 435 sacks 50-50 Poz. "A" w/2% gel, 6 1/4#/sack Gilsonite and 1/2% CFR-2. Cemented second stage with 200 sacks "Lite-Wt." w/1/2% CFR-2 and 565 sacks as in first stage. Both stages preceded with 500 gallon "Mud Flush." Plug down 5:45 p.m. 2-13-72. Rig released 2-13-72.
