This well has been TA'd since 10/5/88. Extension of TA status is requested as this well is a direct offset to the Ruddock #3 which is a Pictured Cliffs producer. If the casing should fail in the #3, #7A would be used as a replacement well.

Upon BLM approval of this proposal, Graham Royalty, Ltd. will perform a Casing Integrity Test and notify BLM 48 hrs prior to the test.

Note: Casing tested to 500# on 9/25/91, held okay.
